Finally arriving home from this devastation on February 19, 2014, she has suffered several complications from severe burns that ravaged over 75% of her body including amputation- Our support of Sa'fyre in 2016 \$500 ; Logan Siciliano, age 5 was born on January 19, 2011 diagnosed with Marfan Syndrome (MFS) - a genetic disorder of connective tissue which holds all parts of the body together and helps control growth. MFS affects the heart, blood vessels, bones, joints, eyes, lungs and skin. He was also born with leaky heart valves and an enlarged aorta causing congestive heart failure. Logan had undergone open heart surgery in 2011 to repair 3 valves and replace part of his stretched aorta. He was nearsighted requiring him to wear glasses. We assisted Logan and his family with medical expenses & sadly funeral expenses. Logan gained his angel wings on February 15, 2016.\$2004 ; James Deere is a double amputee with an 'anoxic' (without oxygen) brain injury. He was a healthy, smart, vibrant, fun-loving boy until he was struck with a near fatal sepsis infection at 3 1/2 years old. He is still all the things I described, but now is trapped in a body devastated by sepsis. He is now healthy, but requires much care. He lost his ability of meaningful speech since the insult, but he continues to try to communicate. He is dependent on an adult for all tasks of daily living. James is in weekly physical therapy \$2060. Daniel Dingley, age 11 was trapped in his burning home on April 2, 2010. He was found unconscious and was rescued by the Green Island Fire Department and resuscitated and given lifesaving medical treatments by Empire Ambulance Service. Daniel has undergone several surgeries since the accident and we continue to assist with medical and travel expenses during his ongoing treatments - \$370 ; Parker Ragone, age 5 was diagnosed in 2011 with Pre B Acute Lymphoblastic Leukemia (Pre B- ALL), an aggressive cancer of the blood. Parker who is in remission and doing very well with the maintenance portion of his treatment receiving physical, speech and occupational therapy. He is expected to take daily oral Chemotherapy into 2015. His treatments caused side effects including fatigue and neuropathy (damage to the peripheral nerves, especially those that branch out through the arms, legs, fingers and toes). Parker understands his condition referring to it as "Kemia" and knows that sometimes he can't do things that other children his age can do. Parker and his family are doing well.
