situations): ; Sa'fyre Terry, age 7 was the sole survivor of a ferocious house fire in Schenectady, NY during the early morning hours of May 2, 2013 that claimed the lives of three of her siblings and her father. Finally arriving home from this devastation on February 19, 2014, she has suffered several complications from severe burns that ravaged over 75% of her body including amputation- Our support of Sa'fyre in 2014 -\$2,393.07; Logan Siciliano, age 4 was born on January 19, 2011 diagnosed with Marfan Syndrome (MFS) - a genetic disorder of connective tissue which holds all parts of the body together and helps control growth. MFS affects the heart, blood vessels, bones, joints, eyes, lungs and skin. He was also born with leaky heart valves and an enlarged aorta causing congestive heart failure. Logan had undergone open heart surgery in 2011 to repair 3 valves and replace part of his stretched aorta. He is nearsighted requiring him to wear glasses. We assisted Logan and his family with medical & travel expenses - \$4,750; Daniel Dingley, age 10 was trapped in his burning home on April 2, 2010. He was found unconscious and was rescued by the Green Island Fire Department and resuscitated and given lifesaving medical treatments by Empire Ambulance Service. Daniel has undergone several surgeries since the accident and we continue to assist with medical and travel expenses during his ongoing treatments - \$3,323.09; Parker Ragone, age 5 was diagnosed in 2011 with Pre B Acute Lymphoblastic Leukemia (Pre B- ALL), an aggressive cancer of the blood. Parker who was in remission and doing very well with the maintenance portion of his treatment receiving physical, speech and occupational therapy. He is expected to take daily oral Chemotherapy into 2015. His treatments caused side effects including fatigue and neuropathy (damage to the peripheral nerves, especially those that branch out through the arms, legs, fingers and toes). Parker understands his condition referring to it as "Kemia" and knows that sometimes he can't do things that other children his age can do. We supported this young family through several difficulties along their path - \$4,863.62; Reese Johnson, age 14 from Ballston Spa underwent surgery in March 2014 to remove a mass from her mouth (Jawbone), after being diagnosed with Ewing Sarcoma- a rare form of bone cancer. She is undergoing Chemotherapy treatment 5 days a week- every other week for 10 months. Reese is a positive, outgoing person who feels confident that upon completion of her treatments she will be fine! We welcome Reese to our foundations' family and we pray for her speedy and complete recovery - \$2,564.76; Kaiden James Crowley, was diagnosed with Neuroblastoma and a growth was found on his adrenal gland. We assisted Kaiden and his family with medical & travel expenses - \$500; Paige Grimmik, In 2008, Paige was Diagnosed with Neurofibromatosis Type 1, (NF1) and has received several MRI's to closely watch this disease. In 2013 she underwent surgery to remove a tumor that grew on her spine, heart and lung.\$150; AJ Ballard, He has MeCp2 Male. This is very similar to Rett syndrome in females--and is extremely rare in boys. This condition is currently non-reversible. AJ is now on the ventilator 24/7 and is completely non-mobile.\$885.48; Sophia LeClaire, Sophia was diagnosed with Congenital Disorder of Glycosylation (CDG)- Rare metabolic disorder, a genetic condition with an as yet undetermined defective gene resulting in metabolism problems and an enzyme deficiency.
